Here is the sworn testimony of a Senior Technical Advisor in <u>just one</u> of the many offices of the IRS, telling us what the expression "numerous" really means:

Now, filings by Americans educated through reading <u>Cracking the Code- The fascinating Truth About Taxation In America</u> (CtC) have been being processed through at least eight different IRS offices all over the country since 2003. You can see the ID's of each by looking at the face of <u>any given refund check or notice</u>, which bears the office designation of "Andover", "Fresno", "Ogden", San Francisco", Philadelphia", and so on.

So, let's do the math:

At the time of this writing (again, August, 2014) there are about 1,100 examples of these CtC-educated claims and the good consequences they produced <u>posted for examination</u> (along with the filings themselves, in many cases). Those 1,100 or so examples add up, in amounts recovered or retained by their proper owners, to a total of \$11,852,726.98-- an average per victory of approximately \$10,775 (and every one <u>issued only after rigorous vetting</u>).

So, again, let's do the math:

200,000 refunds x \$10,775= \$2,155,000,000. That's \$2.15 billion-with-a-"b".

In fact, in April, 2015, a DOJ Tax Division attorney admitted that CtC-educated claimants had recovered or retained billions, calling the book's revelations something to which the IRS is "seemingly vulnerable". He called those revelations a "scheme", but I'm sure he hoped the spill-out crowd in the courtroom that day wouldn't realize that the only "scheme" to which the IRS could be "vulnerable" is the one imposed upon it by the law...
