To Whom It May Concern:

Thank you for your correspondence dated August 17, 2016 (copy enclosed for your reference) and *partial* refund of \$890.00. Attached please find my response to that correspondence dated August 27, 2016 sent via certified mail 7014 2120 0002 8567 1710 and delivered on August 30, 2016. To date I have not received a reply and have therefore prepared this 2nd Notice.

Please be advised that in 2015 I was an unprivileged worker in the private-sector, not an "Employee" as defined in 26 USC. The private-sector organizations (Inc. and Inc.) characterized payments as "Wages" and filed erroneous tax information returns. I am rebutting their claims, stating that I was a private-sector worker (non-federal worker), working for private-sector organizations (non-federal entities) as defined in 3401(c)(d). I did not hold any federally-privileged positions, so I had no "Wages" as defined in the IRC sections 3401(a) and 3121(a). Attached please find my Internal Revenue Service 2015 Return Transcript which confirms my "Wages" as \$0.00.

We expect a full and complete refund of the balance \$1,940 (\$2,830 - \$890) of our overpayment shown on our 2015 NJ-1040 Form as was done similarly for our Internal Revenue Service overpayment (see IRS 2015 Return Transcript).
